TOWN OF POMONA PARK BEAUTIFICATION COMMITTEE MEETING AUGUST 5, 2019 10:00 draft prepared by js

Chairwoman Joyce Svingala presided. Yvonne Munn, Sheryl Johnson & Becky Filer were present.

Sheryl turned in her receipts to Kelly which are included in the balance below. Joyce's debit card did not work so she had to use her own personal card to purchase the food items needed for the breakfast and will be reimbursed by the town.

She has since then gone to the Center State Bank and received a new card. The balance in our account is \$10,600.45.

BREAKFAST RESULTS

We served 43 breakfasts. Bud and Linda Linkswiler will cover the French Toast and the Pancakes and Eggs Benedict orders. We sold ½ order of eggs benedict, one order each on the pancakes, 6 orders of French toast, 4 orders on both the bacon and mushroom casserole and 11 orders on the ham and swiss casserole. We sold a total of 7 egg sandwiches and 7 orders of biscuits and gravy. Total food sales were \$192.00 and tips were \$32.00 = grand total of \$224.00.

Pat Mead was out ill, so Joyce took over as cashier and displayed some of our Pomona Park mugs to sell. No luck this time. Next month we will have a full display out there.... keep your fingers crossed. By the way..we voted to drop the price of the license plate covers down to \$8.00 to hopefully sell some and move out the inventory.

Congratulations to Becky and Rick Filer for joining our Beautification Committee. They have been pitching in a lot for a long time and finally took the plunge! A motion was made by Sheryl and seconded by Yvonne to accept Becky and Rick on our committee.

Thanks a million. Also, a special thanks to a few other seniors that have been lending us a helping hand....

A motion was made to accept the minutes of the meeting of July 8, 2019 and seconded by Yvonne Munn. Motion passed.

Motion was made to purchase a small display cabinet with a lock on it for the community center to display the license plate covers and the mugs and hats to sell

The steppingstones are finished for Marjorie Jacobs and Rodney Shefield and have been placed outside. We plan on doing a presentation the Marjorie's husband and Rodney's wife or son at the September meeting.

NEW BUSINESS

A motion was made by Yvonne and seconded by Sheryl to order new Beautification Committee shirts for new members and have extras on hand. Joyce will get a complete order together and ask one of the ladies to place the order for us.

Personalized aprons for all...We can buy bulk bib aprons and Becky volunteered to embroider them for us. It will be determined what saying will be on the front of the apron. Some examples of sayings are "small town.. exceptional neighbors...delicious food made especially for you" OR "from our kitchen to your tummy".

A motion was made by Yvonne and seconded by Becky to purchase 2 new griddles replacing the two old one's hat don't heat up hot enough and not to exceed \$100.00. All 4 griddles are now brand new....

Discussion to change up our menu a little. As of now we will drop the Bacon egg casserole and add the farmers casserole and keep the mushroom casserole and the ham and cheese casserole. We will also keep the pancakes, egg sandwiches, biscuits and gravy, French toast, eggs benedict and add Stuffed crepes. On August 14th 5 of us will be at the community center kitchen experimenting with different types of crepes. To be continued.......

Yard Sale.... Looking to bring in food trucks and food carts to replace our concessions we used to run. Unfortunately, we don't have enough volunteers (young) to help us out and we aren't getting any younger. Joyce was in touch with other surrounding municipalities and Pierson gave the most information. Joyce will give the town attorney the paperwork to go over. In the end "vendor permits" would be issued to those working during the yard sale. Anyone attempting to sell food within the town limits without a permit issued by the town would be asked to leave by law enforcement.

<u>Town of Pomona Park - Town Council & Public Hearing Meeting Minutes</u> Tuesday, August 13, 2019 (6pm)

Mayor Joseph Svingala presided. Council present were Dr. Robert Warren, CarrieAnn Evans, Patricia Mead, James Griffin, Victor Szatkowski and Attorney Sherar were all present. Pat Bergquist was absent.

Mayor Joseph Svingala led in the pledge to the pledge to the flag. Mayor Svingala called the meeting to order at 6:00 pm and welcomed everyone.

Meeting Minutes:

The Mayor requested approval of the Minutes from 7/9/19. Councilwoman Evans made a Motion for approval and it was seconded by Councilman Warren. Vote to approve was unanimous.

Unfinished Business:

Clerk gave Jeff's maintenance update showing the maintenance time allocation for the month of July. There was a picture of the newly painted Maintenance Facility. Jeff had prepared an update on the tree maintenance of the Town.

Councilwoman Evans gave a Beautification update on the past breakfast for August they took in \$224. They served 43 breakfasts and they are in dyer need of volunteers. They decided to lower the license tag covers to \$8. The committee is going to purchase display cabinets for the Community Center to display the items for sale. Becky and Rick are helping out. The committee is going to buy new shirts.

Clerk Assistant, Kelly gave an update on the financials and the balance totals in all accounts showing Beautification at \$10,804.45, 1-5 Cent \$39,974.52, Better Place \$273,561.51, General Fund Money Market \$238,869.39, General Fund \$31,939.44 for a total of \$595,149.31.

New Business:

Clerk Fontana explained that we had received 1 sealed bid which was opened in the presence of the Mayor, Clerk and Clerk Assistant. The bid was from Janet Ramirez and was for \$6000. Councilwoman Evans asked when we sell property who sells the processing fees? Clerk explained that the buyer pays the outstanding taxes, the closing fees will be nominal. Attorney Sherar will prepare the Deed and we will transfer that over so there will be taxes for the sale and recording clerk fees and doc stamps, around \$100 or slightly over. The Council can decide who will pay those fees. Attorney suggested the Town pay the closing fees. Councilwoman Evans made a Motion to accept Ms. Ramirez offer of \$6000 for the 117 Hill Street, Pomona Park, FL 32181. Councilman Griffin seconded the Motion. Councilwoman Evans revised her Motion to include that the Town will pay the closing costs, seconded by Councilman Griffin. Ms. Ramirez came up to the podium with her son as an interpreter. Clerk asked if she had any questions? Ms. Ramirez said no. Ms. Ramirez asked when does she need to pay? The Clerk said that we will

have our Attorney draw up the Deed as well we have to do an Ordinance to legally convey that property from the Town to you, so we are looking at 2 months to accomplish this. Attorney Sherar said that she should go ahead and make the deposit now and have the funds clear and then at our next meeting in September we will need to pass something and then we'll have to bring it up again in October. He said we will take the whole amount now and that way we know we've got the money and we can go ahead with it and not wasting our time. Clerk said you can bring it tomorrow and we will provide a receipt to you. Ms. Ramirez agreed. Unpaid taxes can be paid at anytime to the County. Attorney Sherar said there will be no taxes for this year, there is one year of outstanding taxes that you'll have to pay. You won't have to pay taxes again until next year. Clerk provided the outstanding tax notice to Ms. Ramirez.

Clerk explained pictures on Pleasant St. from the 2 Men and a Tree, where they are dumping tree debris. The owner Michael Mills has moved the piles off of the right of way and has dug a hole that he is putting tree debris in. Attorney Sherar thought that he was going to bury it. Councilmembers have expressed concerns to me that they do not want that to be a dump site or a burn site. Councilman Griffin said that the hole doesn't look deep enough to bury, it looks like a burn pit and that would smoke up the entire Town. Clerk invited him to the meeting, he has been informed about the burning issues and provided documentation that burning is not allowed. Shirley Griffin asked if there is a rule that he cannot bring it from his jobsites into our Town and then burn it? Attorney Sherar said that we've got a problem that we have AG and some places that don't and there are some arguments that can be made depending on what he's doing. He can't use it as a dump. I guess he can bury it but he'd have to bury it on a consistent basis. Burning it is a violation of all sorts of statutory issues with the Department of Forestry. If he was hauling it in and mulching it then he could probably do it. I have said this before, that I know the guy and have used him to do some work for me. I've talked to him when this thing first came up and I told him that he has to get his stuff off the right of way. Mike told me that he wasn't planning on burning it, that he was planning on mulching it. Some of this stuff is too big to mulch but he could get a grinder, so I don't know what he is going to do. I suggested to Donna that she get a hold of him to have an intelligent discussion, but I guess he chose not to return her phone call. He can't use it as a dump, he can use it to process but he can't pile it up there at nauseum and then say, "oh yeah, I'm going to process it, I'm going to process it". There comes a point in time that obviously he's not going to process it. At least if he starts to burn it the Department of Forestry would shut him down because you can't burn stuff like this. Mayor said that when he called 911 because he wanted a record of what was going on at East Main St., the Fire Department went and they couldn't do anything and they called Forestry and they told them to put it out and said it has to be 25 feet from the forest line. I think DEP would get involved. they used to let you burn hurricane debris, but you can't do that anymore. Its kind of wait and see what he does, if he leaves it sitting up in piles a month from now, write him up on code enforcement for having a dump. If he starts running the stuff through a chipper and creates a mulch pile, I don't know if you can argue that's an agricultural activity cause you're processing an agricultural product which are trees. You can argue that its really an industrial activity. We have to wait to see what he does. He's bringing material offsite to this site and dumping it. As far as burying it I don't think we can stop anyone from burying it. Clerk said hopefully he understands that makes his property useless because if he goes to sell it he would need to disclose that because it could become a sink hole. Attorney said that would be something he has to deal with if he sells it 40 years from now. Owner steps to podium: Michael Lloyd Mills, 202

East Main St. Clerk explains that we were discussing him placing tree debris on the property on Pleasant St. and we are not sure what his intentions are. We know that we do not want it to become a dump for you cutting trees down in other areas and then dump it there. Mike said I was trying to fill it in and get rid of some of it from my house to there. I'm trying to go to the dump but its \$180 a load every time I go, its kind of expensive. With that being said, I'm to get it all buried, what I can and then taking some to the dump to get it out of my house because I didn't know I couldn't burn that close to the city. Mayor asked, so that stuff you're putting over there is coming from Broward? Mike said, some of it is and it was new stuff as well. I dug the big hole there and fill it in and then dig another big hole and fill it in and then start hauling to the dump. If I had to pay to haul all that stuff it would probably be \$2000-\$3000. Councilman Griffin asked, so this that you're putting on the property is actually grown here in Pomona Park or are you importing them from areas outside of Town. Mike said, no some from George Town, Crescent City. Councilwoman Evans asked after this hole is filled what do you do? Make more holes? Then what do you do with this property? Mike said nothing, it will sit there empty, I'll grade it off and then it could be built on. Councilman Warren asked, what would you build on top of those buried trees. Mike said, the next person that buys it can figure that one out. Clerk asked if Mike just bought that 5 acres? Mike said, no it belongs to David Perkins, he's letting me put the stuff there. Councilwoman Evans asked, how do we know he has permission to dump on this property. Mike said, call David Perkins, I share a lot of business with him. Clerk asked Mike if he could provide his telephone number and Mike said he doesn't know it off the top of his head, but we can get it from Geo because they are partners. Clerk asked, what it your time frame for getting that stuff buried? Mike said, 2 weeks at the most. I've got 3/4 of it in there but I'm trying to move as fast as possible. Judy Szatkowski asked, does David Perkins know that you're burying that wood because it will rot and sink and if he goes to sell it its his problem. Mike said, I don't think he wants to sell it because he doesn't care but I have someone that wants to buy it and they know what I'm doing there. Shirley Griffin asked, you don't have a problem living in the community and putting that stuff on our right of ways. Mike said I was burning it until I go stopped. When I was burning every day, I didn't have a problem, but it rained and backed me up on burning. Shirley asked, how long have you been doing tree service? Mike said maybe 6 years. Attorney Sherar explained that you can't run a dump and if you bury it you are running a land fill. The main issue the council has is how long is it going to be going on for? Mike said, I'm not going to do it anymore. I'm not going to burn at my house and I'm not going to dump over there no more. My thing is that I've got to get rid of what I've got and if you want me to go in and take it to the dump, I will, but on the other hand is there a chance that I can burn 1 day with what's there and be done with it? Councilwoman Evans asked, don't you charge your clients to cut down the tree and remove it? Mike said, I'm so cheap I don't. I'm an innocent person trying to make a living and I made a mistake by loading it all over here. Clerk said, we respect that its just that we want to make sure that going forward it's done the proper way. Mike said, I'm trying to get it done the way you guys want it, that's why I'm here asking how you want me to do it? Attorney asked would the Dept. of Forestry give you a permit to burn it. Mike said yes and if you don't have a problem with that, I will burn it all and be done with it. Clerk said, from the Town office standpoint, we've gotten a lot of phone calls just from what you've been doing so far. Kelly stated that there is an elderly home behind the ball field, a nursing home. Burning would probably not be good for them. Councilwoman Evans said there are children that play ball in those ball fields and you would have smoke continually on them. Clerk said that the council would be setting a precedence if we allow him to burn. Attorney said,

we can't pre-crime him. He's got to do something, be it right or wrong, he's got to do something before we can take any kind of action. Based upon the conversation I've had with him before and what he's saying now, we can't authorize him to do anything. Clerk said, it sounds like Michael, you want to work with the Town. He said yes. Clerk said we need a good tree man, if you can get this cleaned up we can talk about that. Councilwoman Mead said well it sounds like you are planning to continue to bury it there. Mike said no that was the stuff at my house but since you guys don't want me to do that I won't. It may take me 3-4 weeks to get all the stuff at my house to the dump. I've got a 25 yard dumpster and there's probably 25 loads. Councilwoman Mead said we need a good tree man for the Town, but we would like you to include enough in your bid so that you have enough to make a profit and still take it to the dump. Mike said he's always been the cheapest and he thought he was moving to a perfect spot to burn. Attorney said, in the middle of Town. Mike said I do have a chipper in St. Pete I just haven't had the time to go get it. Clerk said, it sounds like Michael is going to start working on getting rid of this and then we'll keep an eye on it and see if there is any Code Enforcement that might come from it. Councilman Warren asked, you're not going to add anymore wood to the site, you're going to cut it up, burn it, bury it? Mayor said, be careful we are not authorizing you to do any of that. Mike said, I will call the fire department and work with them and see what they say and take into consideration the ball field and 50 feet from houses. Attorney said, let's check on it in a month and we'll see if he has taken care of it. Councilwoman Evans said, I have concerns that the property doesn't actually belong to him. Attorney said, that's between him and the guy it belongs to. It has nothing to do with us. Two issues, one is if I dump toxic chemicals on your property, I am responsible to clean them up and so are you. Even though you are an innocent 3rd party and somebody was just in there.

Councilwoman Evans said, at one point we had talked about looking into a chipper because our maintenance place because of people not wanting us to burn and we could chip and use the mulch around Town. When our big dog comes back can you ask him to look into that? Clerk said that he will be returning after the budget cycle so I can ask him about it. I just checked with him on an edger. Councilwoman Evans said we need to do something where we're not bothering Ms. Georgia Mae. Clerk said she will check on that with Bruce. I also spoke with Jeff about a dump wagon they want. You pay around \$6000 and they can fill it up and take to the dump when full. That may be cheaper in the long run instead of getting dumpsters placed and hauled.

Clerk discussed the Sheriff Deputies on duty. That previously the Council approved the Deputies for 2 hours a week patrolling 3 streets which is about to end. The 2 hours a week has been very effective. If you've been reading my clerk's notes then you've been seeing all of the citations, 20 or more warnings, 13 citations, 1 drug arrest. I would like to propose to the Council that you consider extending that in the budget for every week next budget year. Mayor said, I love the idea. We are receiving \$6000 for a piece of property and that would pay for 2 years of a Deputy doing what he's doing now. Councilwoman Evans asked how much is that now? \$60 a week. Clerk said, you've got something good going on right now that is a step in the right direction. You've got money to be able to do it. It's \$3100 a year. The days and hours will stay as 2 hours per week and the Deputies will sign up at will. Councilman Warren asked, are we getting any revenue from the citations? Attorney said yes, we receive a small amount, its not a revenue generating thing. Clerk said, you're not going to get back what you've paid but what you're receiving is something you haven't had in years. Law and order in this Town.

Councilwoman Evans made a Motion to extend the 2 hours per week for the Sheriff Deputies through this current fiscal year and through next year. Councilman Warren seconded the Motion. Vote was unanimous to approve the Motion.

Attorney saw Charles Overturf and he brought up if you want to make any charter changes, there is a procedure in the Charter to do that and should be included in the November 2020 election. This means we would have to be done with our procedures by August of 2020 because that's his deadline to get it on the ballot. Clerk said, I have scheduled Charles Overturf to attend our September council meeting to discuss this.

Councilman Griffin said, I am still for a 5 person council, it makes sense. Councilwoman Evans said, you can't keep beating a dead horse, you've already brought it up and you can't keep bringing it up. Attorney said, if he wants to do it, it is his right to do it. If he wants to introduce an Ordinance to change the Charter, Donna and I will draft it, notice it, so that everyone in the Town has the right to come in and say whatever it is they want to. Maybe you and your spouse will beat the street and pack the chamber with people that want to reduce it to 5. It gets to be hard to find enough people to serve on it. The amount of work that you do and the amount of money that you get paid there's no incentive for someone to do it. Art Blount said, you've had 7 on the Council forever here, you can't knock success. You don't need to change to 5. Clerk said, all of the Towns around here are a 5 person council. Attorney said the typical number is 5. The Mayor said, the soonest we can get it in is 3.5 years.

Councilwoman Mead said, that several years ago we had a list of things that we wanted to change on the Charter and they were all defeated except one. If we could go back and figure out what they were and change the wording and see if those things need to be done. Attorney said by the time Donna and I look these things up, the normal course of things will be April, May of next year. Councilwoman Mead said, that was the year everybody voted no on everything.




