Locks and Cameras at the bathrooms for the beach Dr. Warren: Dr. Warren, Martha Mann, and Andrea met with VKA camera company on June 16. It was recommended that the door frames be replaced before any hardware can be installed. The proposal came back to use a latch and pull handle, and it is very costly. The FCC has come out with some new issues with using the camera system from China. We will put the cameras to the side until a new source can be found. The keypad could be put in the AV room to be able to use the locking hardware. Mayor Svingala reminded Dr. Warren that we have talked about waiting until the grant is completed at the beach before we move forward with anything. Martha Mann spoke about the camera system. She mentioned purchasing a different camera system than what was quoted from VKA.
